    - Space rental fee is 57,900 JPY (Japanese Yen) per m<sup>2</sup>.

    - The space area is either 70 m<sup>2</sup>, 50 m<sup>2</sup>, 40 m<sup>2</sup> or 20 m<sup>2</sup> and the maximum height is 3.0 m.
    - Additional fee for the corner booth: 30,900 JPY per booth.

  - (2) Unit with basic fittings

Three types of below standard booths are available with a basic decoration. They are all provided with assembled-panels. Please refer to the attached drawings.

Type A booth (6 square-meter type):

- Booth size: 3.0 m (width) x 2.0 m (depth) x 2.7 m (height).
- Booth rental fee is 658,300 JPY per booth.

- Additional fee for the corner booth: 14,400 JPY per booth.

Type B booth (4 square-meter type):

- Booth size: 2.0 m (width) x 2.0 m (depth) x 2.7 m (height).
- Booth rental fee is 462,900 JPY per booth.

(324,000 JPY for JIRA member companies)

- Additional fee for the corner booth: 14,400 JPY per booth.

(10,300 JPY for JIRA member companies)

Type C booth (3 square-meter type):

- Booth size: 2.0 m (width) x 1.5 m (depth) x 2.7 m (height).
- Booth rental fee is 307,800 JPY per booth.
   (216,000 JPY for JIRA member companies)
- Additional fee for the corner booth: 12,400 JPY per booth.

(8,300 JPY for JIRA member companies)

Note: In case of applications exceeds the total number of available booths, preferences for JIRA members or past experiences will be considered for the selection.

6. Exhibition spaces for related medical societies and research institutions

At the JSNM 2018 Exhibition, exhibition spaces are available exclusively for related medical societies and research institutions that are in conformity with the exhibition purposes set by

JSNM.

(1) A unit of 2.0 m (W) x 1.0 m (D), equipped with a power outlet (500w), a standard

signboard, a desk (Length 45 cm), and 2 chairs.

(2) The fee is 108,000 JPY (tax included).

(3) The locations are dedicated areas for the units. Please contact Exhibition Secretariat

(4) If the exhibitor is deemed not to be in conformity with the exhibition purposes set by JSNM,

the application may be rejected.

Final notice of booth allocation will be sent together with the invoice (bill) for the payment on

September 3 (Mon.), 2018. The applicant is requested to settle the payment by September 28

(Fri.), 2018. All the bank transaction charges shall be borne by the applicant

10. Cancellation after the booth allocation:

The following cancellation charges shall be borne by the applicant in the case that the

applicant cancels a part or all of its allocated booths for its own reasons:

a) From Aug. 6 to Sep. 3: 20% of the booth rental fee.

b) From Sep. 4 to Sep. 28:50% of the booth rental fee.

c) From Sep. 29: 100% of the booth rental fee.

11. Cancellation of the exhibition due to an occurrence of a natural disaster

When the organizers have decided it is not possible to hold the exhibition due to an occurrence
of a natural disaster, your booth rental fee will be refunded, with an expense account being
deducted according with the state at the time of call-off.

## 12. Booth structure and Electricity:

- a) In case of the exhibition booth unit without fittings, the space area is provided either 70 m<sup>2</sup>, 50 m<sup>2</sup>, 40 m<sup>2</sup> or 20 m<sup>2</sup>.
- b) In case of the exhibition booth unit Type A, B and C, it is equipped with the basic decoration. A fascia with a company name, its illumination lamp, sidewalls, floor carpet and a power outlet are provided. Please refer to the attached drawings.
- c) Electricity: Primary power cabling fee and consumption fee shall be separately calculated, billed and settled for each booth.

The same method shall apply for any additional electricity-cabling request.

- d) The committee may adjust and change the application contents in the case any problems arise. In this case, the committee will soon advise the applicant of the change with a request of its acceptance.
- 13. Schedule of bringing-in and removal of the exhibition goods:
  - a) Bringing-in and adjustment:

From 9:00 AM Nov. 13 (Tue.), (planned) (will be informed in case any change arises) Cleaning up of the exhibition area will start at 18:00 on Nov. 14 (Wed.).

b) Removal and bringing out of the goods: 12:30 to 17:00 Nov. 17 (Sat.), (planned)

All the goods shall be brought out of the exhibition area during this time period.

- c) Vehicle parking place in the abovementioned days: (The details will be informed later).
- 14. Floor weight capacity: 5,000 kg/m<sup>2</sup> (On the pit, 1,000 kg/m<sup>2</sup>)
- 15. Meetings for explaining the exhibition and lottery of booth selection Meetings for explaining the exhibition and lottery of booth selection are not planned. The applicant is requested to be dependent on the Exhibition Committee's decision for booth selections.
- 16. Exhibition manual and submission documents:

The exhibition manual and related submission documents will be sent to the applicant on Sep. 3 (Mon.). And the related submission documents should be sent to Exhibition Secretariat of JIRA via e-mail by Sep. 28(Fri.).

#### 17. Others

- The opening ceremony will start at 9:30AM, Nov. 15 (Thu.).
- Smoking is prohibited in Exhibition Hall.

## 18. Handling of personal information
